Sub.: Approval of your "**Laboratory**" For Conducting Physical and Chemical tests as per Indian Boiler Regulations, 1950.

Gentlemen,

With reference to your letter No. NIL, dated 03-08-2021, and subsequent visit of a competent person of this Directorate to your workshop on 25-08-2021, for the purpose of verification of all the testing facilities, manpower, quality systems, etc., I have to inform you that same are found satisfactory. You are now provisionally permitted to conduct "**Physical and Chemical tests**" as per the provisions in Indian Boiler Regulations, 1950 & its latest amendment and Maharashtra Boiler Rules, 1962 under the supervision of this Directorate for a period up to 31.12.2021, subject to the following terms and conditions:

- 1 All test specimens received from various clients should be properly identified, stored, prepared and handled carefully at all stages of testing. All such specimens should be offered for transfer of stamp whenever necessary.
- 2 A clean and pollution free environment should be maintained at the place of test and good housekeeping practices should be followed.
- 3 All tests should be carried out in the presence of Competent Person of this Directorate. All such reports should be signed by your qualified and authorized person and also signed by the Competent Person as witness. The reports should then be submitted to the Director of Steam Boilers, (M.S.), Mumbai-51, for scrutiny and acceptance. A record of all the tests should be properly maintained in a register. Secrecy of the record must be maintained in order to safeguard the interest of the customer.
- 4 All the testing machines should be calibrated periodically in the presence of competent person of this Directorate.
- 5 As far as possible you should maintain adequate literature, reference codes and latest information about testing practices for ready references.

- 6 As per rule 152(3) of Maharashtra Boiler Rules 1962, any change in testing related staff should be immediately informed to this office.
- 7 In the event of any failure in adhering to any testing procedure, the Director reserves the right to revoke and cancel this approval.
- 8 As per rule 155 of Maharashtra Boiler Rules, 1962, approval may be withdrawn if-
 - a. It is revealed that this approval is obtained by furnishing incorrect or false information.
 - b. No testing activity is carried out for a continuous period of six months.
- 9 All testing fees as per rule 39(17) (a) of Maharashtra Boiler Rules, 1962 should be deposited in Government Treasury, prior to request for visit of Inspecting Officer for witnessing the tests.
- 10 Application for renewal of this approval should be submitted one month in advance of the expiry date, along with original receipted challan for payment of fees for the purpose.
- 11 All instruction and directive of this directorate should be strictly followed.
